



## Beaver County, Pennsylvania GIS Data Distribution Procedure

The Beaver County GIS data is available in Esri Personal Geodatabase format or Esri shapefile format to the public for a fee and is subject to the following terms and conditions:

1. The information is to be used only by the purchaser and may not be duplicated, reproduced, assigned, transmitted, or delivered in whole or in part, in any form, to any other person, party, organization, entity, or successor.
2. The County of Beaver makes no warranty whatsoever, neither expressed nor implied, with respect to the accuracy of the GIS data or fitness for use of the information by the purchaser.
3. The purchaser releases the County of Beaver, its officers, departments, authorities, agencies, and employees from any and all claims and liability associated any way whatsoever with the GIS data or the purchaser's use thereof.
4. The parcel boundary information should not be interpreted or accepted as an individual property survey for deed transfers or other legal transactions.

The fee for obtaining the data is as follows:

1. \$100.00 per municipality *or*
2. \$5,000.00 for the entire county
  - a. \$1,500.00 maintenance fee (see page 3 for details)

## **Maintenance Plan**

A yearly maintenance plan can be purchased for \$1,500.00 annually. The maintenance plan has the following terms and conditions:

- The entire county GIS database must be purchased at the price of \$5,000.00
- A maintenance fee will be offered to the purchaser to receive the next current year tax map Public GIS data for the year following the initial purchase
- The annual maintenance plan fee is offered to the purchaser via an invoice at the time of the next current year tax map release.
- The fee must be paid every year. If the purchaser skips a year of maintenance, any future request for GIS data will be treated as a new purchase at full price.
- The billing date for the maintenance fee will be yearly; typically during March. The purchaser has until December 31 of the current year to pay the maintenance fee in order to receive a delivery of the current year Public GIS data, and keep the plan active.

## **Availability of GIS Data**

When a Public GIS data purchase is made, the purchase is for the current year data. The current year starts on January 1 and ends on December 31. If the current year data is not available because it has not been finalized, the purchaser will be sent a copy of the latest available GIS data and receive a copy of the current year Public GIS data when it is available at no charge to the purchaser. This applies to those who purchase the entire county GIS database or individual municipalities.
